### Training Course (1 Day)

This course is designed for Students who have completed TMI1 (Category 1), have experience of setting up at least 12 temporary traffic management types on low volume roads and will now be responsible for traffic management implementation on high volume roads (Category 2). The course includes knowledge training and assessment, practical training and the South Australian Localised content training and assessment.

### Practical Experience and Assessment (1 Day) to be completed within 6 months

Access Training Centre will provide a suitable Temporary Traffic Management (TTM) live site work environment for the Student's practical experience with TTM qualified operators to supervise and support Students. Two observations will be completed and documented by a suitably qualified Supervisor while implementing different live traffic setups as detailed on Traffic Guidance Schemes (TGS).

On completion of the practical experience, Students will be required to successfully complete the Final Assessment autonomously interpreting a TGS and implementing the required TTM set up on a live traffic project as advised by the Assessor.

### Course Outcome and Award

On successful completion of the assessment, Students will be issued with

- Statement of Attainment issued by ATC
- TTM card issued by DIT (Department for Infrastructure and Transport)

  - \* At least one month of experience applying skills and knowledge relevant to the RIIS00060 Skill Set
  - \* Experience setting up at least 12 temporary traffic management types including high speed or high volume roads including at least 2 of the following:
    - pedestrian and cyclist controls
    - construction sites
    - lane closures
    - night works
    - shoulder closures
    - use of portable traffic control devices
    - motorways or freeways.

### Student Requirements

- Ability to read, write, speak and understand English
- Students must be at least 18 years of age
- **Students are required to be reaccredited every 3 years**

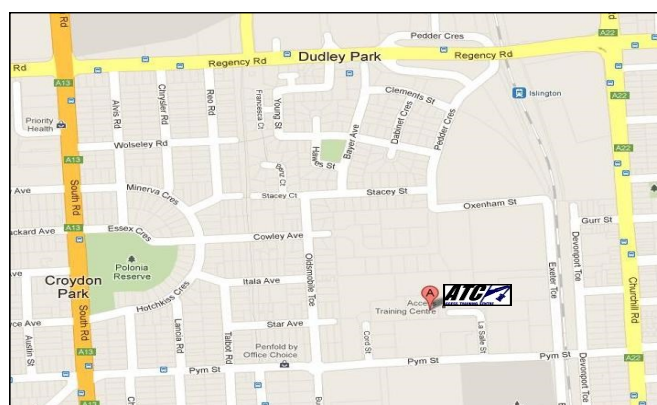
