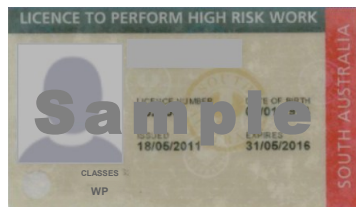

Training and Assessment (2 days) High Risk Licence

TLILIC0005 - Licence to operate a boom-type elevating work platform (boom length 11 metres or more)

Course Objective

To provide the Student with the skills and knowledge to undertake activities related to Boom Type Elevated Work Platform Operation in accordance with the Work Health and Safety Act and Regulations (SA) 2012 as well as Safe Work Australia's National Standard for Licensing Persons Performing High Risk Work.

NOTE: This course does not cover Training and Assessment for Scissor Lift.

Course Outline

Day 1 – Training and Assessment to TLILIC0005 Licence to Operate a Boom-type Elevating Work Platform (boom length 11 metres or more) (VET Unit)

Day 2 – SafeWork SA High Risk Work Licence (HRWL) Assessment

Note: Competency must be achieved to the VET Unit prior to commencing the HRWL Assessment. If Competency to the VET Unit is not achieved, the course will need to be extended and additional fees will apply.

It is **strongly recommended** that Students read the Training Manual prior to attending.

Course Content

- Plan work
- Conduct routine checks
- Set up elevating work platform
- Operate elevating work platform
- Shut down and secure elevating work platform

Course Outcome

On successful completion of this course Students will be issued

- Statement of Attainment
- Notice of Satisfactory Assessment and Tax Invoice
- High Risk Licence (WP) Issued by SafeWork SA **see over page*

Student Requirements

- Students must be 18 years of age to undertake HRWL assessment
- Literacy Requirements
 - * English Language - at a level to understand Industry terminology
 - * Reading - experience in reading and interpreting workplace related documents
 - * Writing - experience in completing written work related documents
 - * Numeracy - understanding weight measurements, metric conversions and basic mathematical calculations

NOTE: RPL pathway is not available for this course due to licensing requirements. Students are required to complete the full training program.

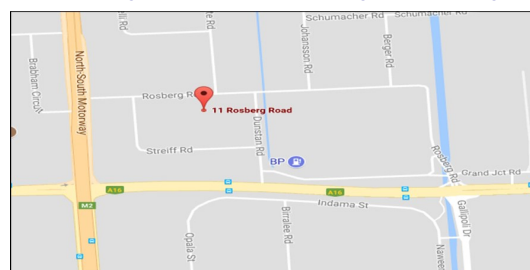

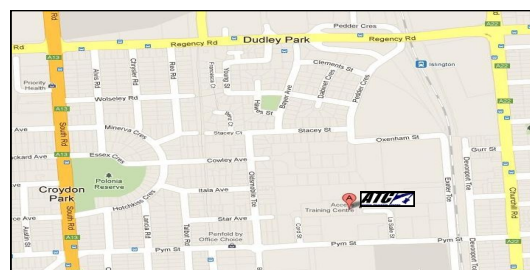

- Two way radios

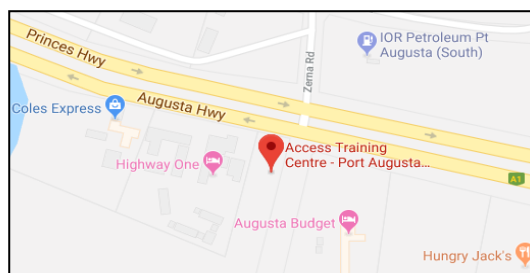

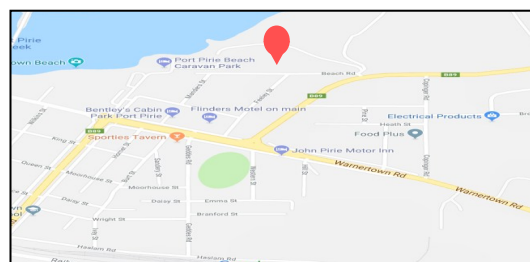
