Facilities Required:

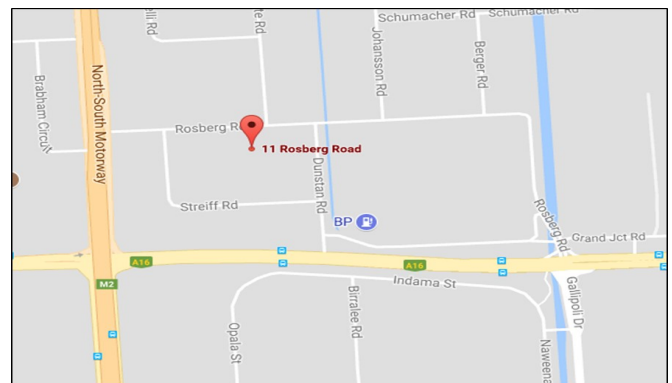
- Whiteboard with marker pens

Equipment and Infrastructure to include (but not limited to):

- Vehicle-Mounted Loading Crane with a capacity of less than 10 metres tonne:
 - Must be fuelled and in a safe, serviceable and compliant condition
 - Must have applicable load chart
 - Must be available on the morning of the course for Assessor to inspect.
- Safe area for Vehicle Loading Crane operation
- Slings and associated equipment in compliant condition
- Suitable loads for lifts
- **Compliant lifting equipment to be used to lift loads**
- Lift plans detailing techniques for lifting loads with associated lifting equipment
